# **Financial Update**

North Shore Beach Property Owners Association



Dear Members,

This is our second letter with an update of the current financial hardships of the Association. We hosted a very well-attended and productive finance meeting on July 29th and we were so grateful to see our members come out to provide their ideas and recommendations. The two major discussions were insurance options and the need to fundraise.

After a very lengthy discussion on insurance options, the board took all of those suggestions and researched them. We have been in discussion with not-for-profit and bankruptcy attorneys who have notified us that self-insurance is not an option as NYS requires our type of association to carry necessary insurances for liability, property, workers compensation, etc. We also requested our current insurance carrier to allow us to increase our deductible and reduce our annual premium, but that request was denied as we cannot make changes until the end of the current policy term. As soon as we are able, we will make that change and continue to look for more affordable options.

#### **Important Facts**

Liability insurance spiked from \$15,000 to \$127,000 which is a 750% increase.

The 2023 budget had a shortfall of almost \$105,000.

The 2024 budget is predicted to have a shortfall of about \$60,000.

There will be one membership rate for 2025 of \$500. No discounts will be available at this time. Extra keys, parking passes and members will have no change.

All members will be charged a \$200 assessment fee to make up for the anticipated budget increase from insurance rates.
