- Items in black means we exceeded the budget, and items in red means we haven't gone over yet.
- Speaks to early bird not included yet for this year so it appears that we are under budget by a lot, but this has not been calculated yet.

- We only had two rain days this summer, so our employment expenses were high, along with the split shifts, gave opportunity for staff to be present even if there was inclement weather for part of the day.
- Road expenses are up. We still have more repairs to do. We will be going over budget. The board has approved this.
- We have a shortfall of \$143k. That can change with Early Bird. We shouldn't have any more expenses for the rest of the year.
- Moving forward, the board is working on the budget for next year. We have to keep in mind that everything is increasing, oil, insurance, etc., and our main expenses total about \$200k each year.
