raised a point that the EB rate does not really address the membership shortfall
wanted to know about the old access gate from Hallock as maybe that can be reused. The board addressed the questions.
question regarding accounts on the balance sheet and who makes up the budget - board or accountant. Mike addressed the question.
Mike concluded his report with some suggestions for the association to look at and to work towards financially in the coming years. He also brought some concerns that should be kept and eye on.
A discussion with members was had regarding the income stream and how expenses have gone up while income remained the same. Increases in membership fees are necessary in the conclusion.
Members wished to know what is the most immediate action to turn the association around. Mike addressed that the finance committee will work on that and report back to the board.
Member suggested doing way with the Early Bird rate
Members addressed that we need more members to attend the meetings.
Members had a question about the Budget regarding the Early Bird Numbers. Mike addressed their questions.
