# Mary Anne Metzak

- Update from August Storm. Friendship will be redesigned. No known information yet. The town installed a fence for protection. Nimbus is not accessible, it's too dangerous. Sand at bottom cannot be moved as it compromises the bluff that remains. Kayaks buried will have to wait for the tide to take some sand away.
- An additional phase of construction began near Soundview and Robin. Focus will be on the Eastern side. But will divert storm water east with new drainage. Bulkheading was approved and permitted by NYS and will be done down below.
- Membership Fees for 2025. No Budget yet. But we wanted to give a number to the membership for 2025 so folks can budget and provide time to save. The board will be adding an assessment. There will be no discounts for 2025. The Membership rate will be \$500. Assessment will be \$200 per membership. The total for 2025 will be \$700. There will be no early payments. Dues will be collected starting January 2025. We will be doing pickups from the clubhouse. Unless you want it mailed, there will be a shipping and handling fee added on. There will be payment options for folks to pay off the membership over a few months. Packets will not be mailed until the payments are fully paid. There will be an added fee for those who wait till May to pay. Any payment after May 1, for example will have a late fee added on.
- We still have items that need to be taken care of. The assessment will be used to offset those big ticket items on our budget.
- Two Ad-Hoc committees: Public Policy Committee and Fundraising Committee were formed. More info will be forthcoming.
