#### President Report

- The clubhouse sustained some damage to the roof from the storm and it's in the process of getting repaired.

#### **Treasurer Report**

#### Micheal Gorton

- \$180,753.01 2020 vs \$179,612.71 2019
  - Difference of \$1,140.30
- Fundraising and Clubhouse revenues are way down due to the pandemic.
- Payroll and beach expenses are higher this year.

## <u>Secretary Report</u> Thomas Buttacavoli

- Announces that the new Bylaws have been passed and adopted.
  - 122 members voted in favor, 18 opposed, 87.1% carried.
- Steve R. thanks everyone for their work on the Bylaws committee.
  - Bob L. thanks Steve for his hard work.
- Motion made by Steve R. for the Secretary to make one ballot for the slate of candidates seconded by Mike G.
  - Thomas makes one executive ballot for the slate of candidates, it's adopted.

# **Beach Report**

## Gina Stacknick

- Thanks the Bylaws Committee and the Secretary for the ballot.
- Webstore was extended and made over \$400.
- The storm made us bring back the lifeguard chairs.
- The kayak racks are designed to handle one regular kayak per spot but we're finding that members are leaving more than one watercraft on their spot as well as personal belongings.
  - Kayak guidelines need to be followed.
- Reminds members that if you reserve a space to please use it.
- Members have till Labor Day to remove their kayaks.

- There was a little bit of damage to the CH from the storm that is being addressed.

- Al H. asks about the PPP monies available and Mike G. says we did apply and were denied.
- Maureen O'Keefe asks if we can raffle off a membership for the 2021 season.
  - Mike G and MaryAnne says we can do that with either eventbrite or our website.

## <u>Security Report</u> MaryAnne Metzak

- Jared has been doing his regular patrols and things have mostly been quiet.
- Tells members to make sure they have their parking stickers displayed in the proper place on their vehicles.
- Staff will begin to issue warnings to cars that do not have their sticker properly displayed.
- Some complaints about social distancing.
  - MaryAnne and Gina S. say there are also large families that spend the day at our beaches.
- Gates should never propped open.
- Masks should be worn on the stairs as well as only one way going up and down the stairs.

#### <u>Bylaws</u> Michael Gorton - Al Hanson, Chair

- Al H. says the committee is open to comments or suggestions and that the new Bylaws are a living document that should be changed when necessary.
- P&P manual being created.
- Steve says the way the governance is structured was revising the articles of incorporation, the second was revising the bylaws, and the third phase is the P&P manual.
- Al H. says once the committee is finished with the P&P the bylaws will be constantly rethought to improve it.
