- We got over a 20k increase in our favor.
- Early bird memberships are the reason for the increase.
- Deep savings has been increased to cover the cost of insurance and taxes.
- October 1st the board adopted the 2021 budget.
- Expecting about 200k in membership income due to the early bird.
- Fundraising budget has been increased a bit.
- Beach income has not been finalized as of yet.
- Rental lease income comes in April.
- Expecting to maintain many of the new members that joined this year.
- More membership expenses due to increased membership.
- Clubhouse expenses are down due to COVID and not the CH not being used as much.
- Carpeted floors in the CH have been updated and was budgeted at the end of last year and work was completed in the beginning of this year.
- Beach expenses were up a bit this year.
- Broadway water main is a capital expenditure project.
- Security was increased from 22k to 25k.
- Paving and road expenses were left at the same levels.
- Administration expenses are under budget so far.
- Property taxes almost spot on in the budget but still have been increased a bit.
- Aiming for a zero budget.
- We are over budget in membership dollars.
- Membership raffle income is almost at 2k
